## Request under the Freedom of Information Act 2000

I write further to your request for information which was received on 31 October 2023, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does hold the information that you require.

For ease of reference your request is set out below and our response follows:

## Your Freedom of Information (FOI) Request:

I am writing to you under the provisions of the Freedom of Information Act 2000 to request information regarding the wound dressings used within Powys Teaching Health Board, specifically seeking details on whether these dressings contain chitosan and information about the source of these wound dressings.

I am particularly interested in the following details:

- 1) The types or brands of wound dressings currently used by Powys Teaching Health Board.
- 2)The sources of purchase for these wound dressings, including the names of suppliers or vendors.
- 3) Whether these wound dressings contain chitosan as one of their components or ingredients.
- 4) If available, any data or studies the hospital has regarding the efficacy of these chitosan-based dressings.

## Powys Response:
