## Request under the Freedom of Information Act 2000

I write further to your request for information, which was received on 10 May 2024, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does hold the information that you require.

For ease of reference your request is set out below and my response follows.

### Your Freedom of Information (FOI) Request:

Under the Freedom of Information Act 2000, I would like to request the following information:

1. An explanation as to who is the CD Accountable Officer for the Kaleidoscope Powys service commissioned by the Area Planning Board.
2. Any policies which set out the governance mechanism for ensuring compliance with health-related legislation within the commissioned Kaleidoscope Powys service.

### Powys Response:

Q1. Kaleidoscope is an external provider, which works in tandem with Powys Teaching Health Board's (PTHB) services such as PTHB Mental Health teams. PTHB's Chief Pharmacist is the Controlled Drugs (CD) Accountable Officer (AO) for the health board.

Q2. Compliance with health-related legislation is managed as part of the contractual arrangements that are in place to support the Kaleidoscope Powys Service.


