Request under the Freedom of Information Act 2000

I write further to your request for information, which was received on 8 April 2025 to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does not hold the information that you require. For ease of reference your request is set out below and my response follows.

Your Freedom of Information (FOI) Request:

Q3. In the past 12 months, on how many separate occasions have formaldehyde levels been recorded that are greater than 0.5ppm but less than or equal to 0.6ppm in the Trust's Histopathology Department?

Q4. In the past 12 months, on how many separate occasions have formaldehyde levels been recorded that are greater than 0.6ppm but less than or equal to 0.7ppm in the Trust's Histopathology Department?

Q5. In the past 12 months, on how many separate occasions have formaldehyde levels been recorded that are greater than 0.7ppm but less than or equal to 0.8ppm in the Trust's Histopathology Department?

Q6. In the past 12 months, on how many separate occasions have formaldehyde levels been recorded that are greater than 0.8ppm but less than or equal to 0.9ppm in the Trust's Histopathology Department?

Q10. In the past 12 months, on how many separate occasions have formaldehyde levels been recorded that exceed 2ppm in the Trust's Histopathology Department?
