Request under the Freedom of Information Act 2000

I write further to your request for information, which was received on 22 April 2025, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) partly holds the information that you require.

For ease of reference your request is set out below and my response follows.

Your Freedom of Information (FOI) Request:

Pursuant to the Freedom of Information Act 2000, I request the following aggregate information for NHS dental practices in Wales for the period 1 April 2023 to 31 March 2024:

Q1. ODS code and registered name of each NHS dental practice.

Q2. Total number of Band 2b UDAs (non-molar endodontic treatments) commissioned by each practice.

Q3. Total number of Band 2c UDAs (molar endodontic treatments) commissioned by each practice.

Please supply the data in a CSV or Excel file. If any element of this request is refused or you consider it to exceed the cost limit, please supply all other releasable data and detail the reason for refusal.

Powys Response:

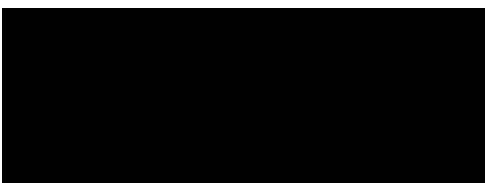
