Request under the Freedom of Information Act 2000

I write further to your request for information which was received on 28 April 2025, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does not hold the information that you require. For ease of reference your request is set out below and my response follows.

Your Freedom of Information (FOI) Request:

I would like to submit the following freedom of information request:

Q1. How many surgeons undertook parathyroidectomy surgery in 2023 and 2024?

Q2. How many parathyroidectomies did they undertake in 2023 and 2024?

Powys Response:

Q1 & Q2. Due to the rural and sparsely populated nature of Powys, we do not have District General Hospital (DGH) within the county and therefore do not undertake parathyroidectomy surgery within the health board. Our residents access their acute and specialist services in neighbouring health boards in Wales and neighbouring NHS Trusts in England.
