Request under the Freedom of Information Act 2000

I write further to your request for information, which was received on 12 February 2025, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does not hold the information that you require.
