### **Request under the Freedom of Information Act 2000**

I write further to your request for information, which was received on 21 February 2025 to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does hold the information that you require.

For ease of reference your request is set out below and my response follows.

#### Your Freedom of Information (FOI) Request:

I am investigating the number of Consultant Midwives/Consultant Midwifery Posts in the UK (including the Channel Islands and Isle of Man). I would therefore be grateful if you would be able to provide the following information:

Q1. Number of Consultant Midwives (headcount AND Whole Time Equivalent (WTE)) currently employed by Powys Teaching Health Board.

Q2. Number of vacant Consultant Midwifery posts (WTE), if applicable.

Q3. Salary band paid/offered to Consultant Midwives (e.g. Band 8b or Band 8c), if applicable.

Q4. Number of Trainee/Assistant Consultant Midwives (headcount AND WTE) currently employed.

Q5. Number of vacant Trainee/Assistant Consultant Midwife posts (WTE), if applicable.

Q6. Salary band paid/offered to Trainee/Assistant Consultant Midwives, if applicable.

Q3. I can confirm PTHB does have a Band 8b consultant midwife post set up.

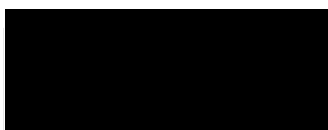
Q4. PTHB does not currently have staff Trainee/ Assistant Consultant Midwives.
