Request under the Freedom of Information Act 2000

I write further to your request for information, which was received on 06 June 2025, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does not hold the information that you require. I can confirm that Powys Teaching Health Board (PTHB) does not have a gastroenterology department. Patients requiring the drugs listed are treated by providers outside of Powys. Powys commissions gastroenterology services from several Welsh health boards and English provider organisations. Unfortunately, in the data sent to us from the provider, they do not currently routinely link the drugs that they use to the indication for treatment. The health board is working closely with providers to ensure that this information can be provided in the future. However, due to the quality of the information currently received by the health board, we do not hold the information requested. We therefore recommend that our providers are approached directly:
