Q6. I can confirm that the framework utilised was an NHS Wales Shared Services tender which were all awarded to Medinet.

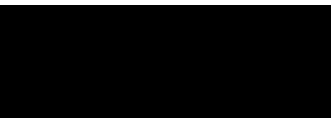
Q7. I can confirm these are direct awards.
