Request under the Freedom of Information Act 2000

I write further to your request for information which was received on 23 October 2025, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does not hold the information that you require. For ease of reference your request is set out below and the Health Board's response follows.

Your Freedom of Information (FOI) Request:

I would like to submit a Freedom of Information request regarding the usage of specific blood products at Powys Teaching Health Board.

Q1. Please provide the total number of patients treated and vials/ grams/ units used for each of the following product categories from October 2024 to September 2025, broken down by brand, where possible:

a. Fibrinogen Concentrate (FC)

- RiaSTAP
- FibCLOT
- Fibryga
- Others (please specify if applicable)

b. Cryoprecipitate

- Pooled units
- Single units

If not all products are available within your health board, please share the data that is accessible to you.

Powys Response:

Powys Teaching Health Board (PTHB) does not initiate treatment with any of the medicines listed; patients may be treated by providers outside of Powys. The

Health Board commissions these services from a number of Welsh Health Boards and English provider organisations.

Due to the complex nature of these commissioning arrangements, not all of our providers indicate the indication for use for each episode of care where these drugs are used. For this reason, PTHB does not hold the data relating to your request. However, the Health Board is working closely with providers to ensure that this information can be provided in the future.

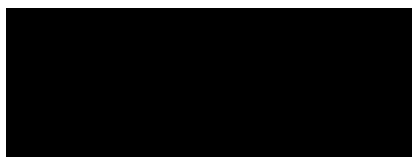
Re-use of Public Sector Information
