Request under the Freedom of Information Act 2000

I write further to your request for information, which was received on 23 September 2025, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does not hold the information that you require. For ease of reference your request is set out below and my response follows.

Your Freedom of Information (FOI) Request:

I am writing to you under the Freedom of Information Act to request the following information:

Q1. How many new patients were treated for Asthma by the Trusts Respiratory Department in the latest 4 month period (April - July 2025) with the treatments I have provided below?

Please can you define a "new patient" as a patient who has received any of the treatments listed below for the first time. If a patient received any of the below treatments before the 1st April 2024, they can be classed as a new patient for the purposes of this question.

- Cinquaero (Reslizumab)
- Dupixent (Dupilumab)
- Fasentra (Benralizumab)
- Nucala (Mepolizumab)
- Tezpire (Tezepelumab)
- Xolair (Omalizumab)

Powys Response:

Q1. I can confirm that Powys Teaching Health Board (PTHB) does not have a difficult asthma clinic, or a respiratory consultant in post. PTHB does not initiate treatment with any of the medicines listed; patients may be treated by providers

outside of Powys. The Health Board commissions respiratory services from a number of Welsh Health Boards and English provider organisations.

Due to the complex nature of these commissioning arrangements, not all of our providers indicate the indication for use for each episode of care where these drugs are used. For this reason, PTHB does not hold the data relating to your request. However, the Health Board is working closely with providers to ensure that this information can be provided in the future.

I therefore recommend that you approach our provider organisations directly for this information:


Re-use of Public Sector Information
